The interested Bidders are requested to inspect the bidding document(s) at the office of the undersigned from 09:00 to 17:00 hours (Except holidays) within 7 November, 2018.

The bidding document in English may be purchased by the interested eligible Bidders upon the submission of a written application to the address below and upon payment of a non-refundable fee of BDT 2000.00 (Tk. Two Thousand only) in cash or in the form of Pay Order in favour of the **Project Director, Export Competitiveness for Jobs (EC4J) Project** during normal working hours. The last date and time of selling bidding document is 7 November, 2018 at 17.00 hrs.
6. Bids must be delivered to the address below on or before 8 November, 2018 at 15.00 hrs. Late Bids will be rejected. Bids will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below on 8 November, 2018 at 15.15 hrs.
7. All Bids must be accompanied by a Bid Security of BDT 5,00,000.00 (Taka Five Lakh only) in favour of the **Project Director, Export Competitiveness for Jobs (EC4J) Project**, valid for 120 days and must be provided by a reputable Bank/financial institution approved by the Bangladesh Bank.
